40 hectares of land covered under Multi Service Cooperative Societies and 110 Aerators (HP Ships) purchased by the society in 2013-14 and 110 Aerators (HP Ships) purchased by the society in 2014-15. The Aerators (HP Ships) were rented to farmers and collection of rent Rs. 18.02 Lakhs from the farmers of the society.

The Society functioning is well and good sound lines. More farmers were utilized Aerators for purpose of Fish Tanks and supplied low cost rent collected from the Members of the Society and more useful to improve financial status of the Members of the Society. The Society deposit growth rate is gradually improved for every year on Multi Service Scheme. The present status of the Society earned profit for the year 2013-14 an amount of Rs.4,46,100/- as per Final Audit Year 2013-14.

The Society also doing Fertilizer business Sales Quantity of 277 MTs, value of Rs.44.42 Lakhs and earned gross profit of Rs.1.20 lakhs.

The Society Gold Loan business will be started shortly with own funds of the society and low interest rate to be collected from the Members in future on Gold Loans.

The Society is having 2 godowns and 1 office building. There are 3 Staff members working in the Society and all the staff are skilled, hard workers and Computer Experts. The Society is also having computer utilizing daily transactions. The Chief Executive Officer of the Society is best computer expert in Amalapuram Division.

The Society was collected Members Deposits to a tune of Rs. 26,00,000/- as on 31.03.2015. The Scheme is more useful to the Members of the society.
